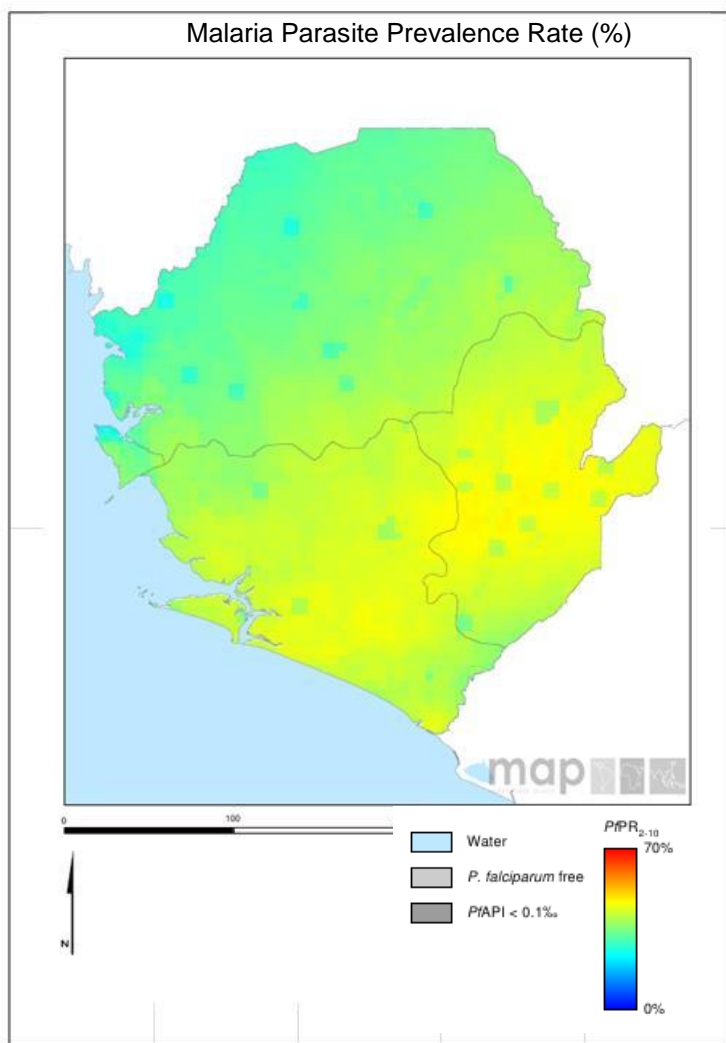


Scorecard for Accountability and Action

Progress

Sierra Leone has banned oral artemisinin-based monotherapies and has introduced policies on Community Case Management for both malaria and pneumonia. The country has secured sufficient resources to achieve universal coverage of LLINs, RDTs and ACTs in 2014. Despite the ebola outbreak, Sierra Leone has completed the universal coverage campaign for LLINs. The country has made significant progress in tracer MNCH interventions including in PMTCT and exclusive breastfeeding and has high coverage of vitamin A and DPT3 vaccination. Sierra Leone has significantly enhanced the tracking and accountability mechanisms with the development of the Reproductive, Maternal, Newborn and Child Health Scorecard.

Impact
