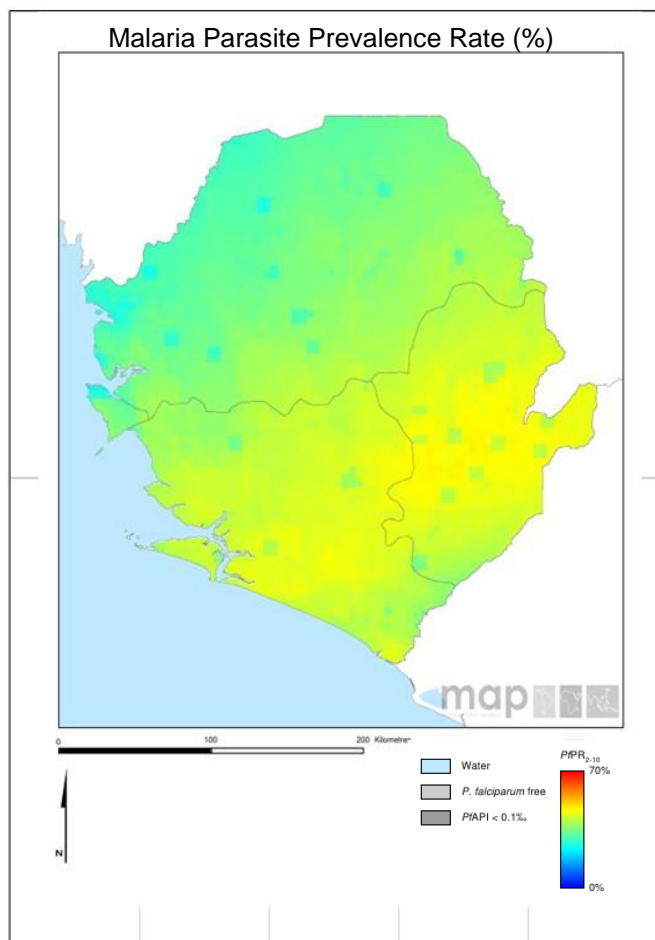


## Scorecard for Accountability and Action

## Malaria

### Progress

Sierra Leone has secured sufficient resources to achieve universal coverage of LLINs, RDTs and ACTs in 2017 and has distributed sufficient LLINs to achieve 100% operational coverage. The country has scaled up the implementation of iCCM.

### Impact

The annual reported number of malaria cases in 2015 was 1,569,606 with 1,107 deaths. WHO estimates that the country has achieved a decrease of 20-40% in the malaria incidence rate and a decrease of greater than 40% in the malaria mortality rate for the period 2010 - 2015.

## MNCH

### Progress

Sierra Leone has enhanced the tracking and accountability mechanisms with the development of the Reproductive, Maternal, Newborn and Child Health Scorecard. Sierra Leone has responded to the challenge of the post ebola recovery. The country has developed and put in place a recovery plan and health systems building strategy and is mobilizing resources for it.

### Previous Key Recommended Actions

Sierra Leone has responded positively to the MNCH recommended action addressing low coverage of ARTs and decreasing Vitamin A coverage and continues to track progress as this action is implemented.
