

Malaria

Progress

Guinea-Bissau has made progress in scaling-up antimalarial interventions and secured sufficient resources to sustain coverage of ACTs, RDTs and LLINs in 2016. The country has distributed sufficient LLINs to achieve operational universal coverage.

Impact

The annual reported number of malaria cases in 2014 was 98,952 with 357 deaths. WHO, through modeling, projects that the country will achieve greater than 75% reduction in malaria incidence for the period between 2000 and 2015.
